They also have a communications coordinator and a director of engagement, understandably so as they are a huge district. LBUSD has four schools and currently has four directors at two separate salary levels. Why does this position need to be increased so greatly from the amount it is currently paying? If the position is revised and the salary changed to the lower of the director positions, it will increase from a cap of \$144,376 to a cap of \$190,131. Even at step 1, it is a \$33k increase.
